Calendar 2024 - 2025 Operation Principles (Revision October 2024) APPROVED

1. Objective of this paper

The purpose of this paper is to seek Hockey Ireland Board approval to the Calendar for the season 2024 – 2025(revision October 2024) to reflect the confirmation that both national senior teams will be participating in FIH competitions within the domestic season. The paper provides the explanatory notes for the agreed operation of the revised Calendar.

Note that the previous Operations and Engagement document that accompanied the Calendar approved by the Board in June 2024 (referred throughout this document as Calendar May24), is included as an Appendix to this document for completeness and to avoid repetition.

2. Approach taken to updating the Revised Calendar

See the Appendix which outlines the engagement process and Guiding Principles agreed and used to develop Calendar May24. The engagement process to develop the Revised Calendar mirrors the approach and principles taking initial input from the HP team, followed by engagement with stakeholders including: the Competition Committee Subgroups (Clubs Outdoor, Indoor, Varsities, Technical Officials), Interpro's, Umpires Association and the Provinces. The engagement concluded with an online meeting to which all stakeholders were invited to in advance of finalising this paper.

3. What has Changed?

Both senior national squads have received confirmation of dates for FIH competitions taking place during the domestic season as follows:

Men: Playing in the ProLeague, with competition slots in December, February and June

Women: Playing in the Nations Cup, Chile, February 24th to March 2nd

The Calendar May24 was built to be adaptable with minimal impact and changes required should one or both teams have competition in February 25.

4. Calendar Approval, Implications and Next Steps

As per the Calendar process, any change to the Calendar must be approved by the Hockey Ireland Board prior to implementation and the revised Calendar and this document are on the Board Agenda for the meeting on 24th October.

Once approved, all stakeholders are required to adjust their own competition calendar aligned with the HI Calendar (revision October 2024) and to adhere to the Calendar Guiding Principles (see Calendar May24) and operational decisions as covered herein.

Once issued, IT SHOULD BE NOTED HOWEVER, THAT THE CALENDAR REMAIN SUBJECT TO CHANGE. The website should always be used to reference the latest Calendar and any change will be announced.

5. <u>Changes to the Operations of the Calendar (Revision October 2024)</u>

The changes noted below should be read in conjunction with the original May24 rules and guidelines in the Appendix. Should there be any conflict, the change noted below takes precedence. The changes outlined below are highlighted on the Calendar spreadsheet in Orange. The Calendar Spreadsheet provides a 'Notes' column in the far right column.

Any issue, query or challenge should be addressed to the Competitions Committee Chairperson in the first instance.

Clubs Outdoor - Changes

- The men's EYHLD1 will commence the mid-season break one week earlier and restart one week earlier, with Round 11 moving from 7th December to 1st February.
- The women's EYHLD1 will restart after the mid-season break one week earlier with Round 13 coming forward to 1st February from 22nd February.
- Both genders will play their next round of EYHLD1 on 8th February, prior to departure of HP players to their respective FIH competition.
- ON 15th February, the 1st XI Cup competitions (AIG ISC KO16, Trophy KO8 and Challenge KO8 rounds) will be held, moving back one week from 8th February. The AIG ISC KO8 also moves one week later from 15th February to 22nd February.
- The AIG ISC KO16 and K08 will be played without HP players who are competing in FIH competition. Note, HP players are confirmed as available to their clubs for the semi-finals (15-March) and finals (10-May), both dates remain un-changed.
- The men's EYHLD1 program continues un-changed on 1st March where both clubs have no HP players (who return to Ireland the day before). Where one team has one or more HP players, then the alternative date for Round 13 will be set by the Outdoors SG with midweek, 15th March and 23rd March being possible depending on the respective club's location and ISC performance.
- 1st March is a contingency date for any EYHL or AIG ISC postponed matches for the women.
- Railway Union women are competing in the EuroNations Indoor 14th 16th February, which will require their AIG ISC KO16 match to be scheduled PRIOR to travel and without HP players.
- Three Rock Rovers are competing the EuroNations Indoor 21st 23rd February. If they progress to the AIG ISC KO8 scheduled for that weekend, the match will be re-scheduled by the Clubs Outdoor SG for a date prior to the 15th March.
- The EYHLD2 program requires a swap in the program to align to the Cups (AIG ISC, Trophy, Challenge) shift of 1 week. As a result, EYHLD2 Round 8 comes forward 1 week to the 8th February.
- The potential double weekend for EYHLD2 clubs depending on success in the AIG ISC KO16, is now the weekend of 1st March. If both clubs fail to progress, then the EYHLD2 Round 5 match will be moved forward 1 week to 22nd February, avoiding a free weekend followed by a double weekend.
- Provinces local league and Cup scheduling to be re-aligned with the shift to the Irish Cups dates (noting the Principles and Operations rules agreed in the Calendar May 24 in the Appendix below).
- Re-scheduling of any HI competition matches will be done in consultation with the Clubs Outdoor subgroup and HP, where applicable.

Clubs - Indoor

• No impact from the Outdoor HP changes.

Schoolboys & Schoolgirls competitions

• No impact from the Outdoor HP changes.

Intervarsities

• No impact from the Outdoor HP changes.

U16 & U18's Interpros

• No impact from the Outdoor HP changes.

Master Interpros

- Note, the Masters program is NOT run by the HI Competitions WG and dates are not known. Dates for the Masters must not clash with HI competitions.
- This requirement will also minimise difficulty in securing Umpires and Officials for Masters events.

APPENDIX – Calendar May 2024 (replaced by above)

Calendar 2024 - 2025 (accompany Calendar for Board approval)

1. Objective of this paper

The purpose of this paper is to seek Hockey Ireland Board approval to the Calendar for the season 2024 - 2025. The paper provides the explanatory notes for the agreed operation of the Calendar plus background information on the engagement and consultation process to build the 24/25 Calendar.

2. Approach taken to building the Calendar

The Competition Review Group (CRG) has been tasked with leading the development of the 2024 /25 Calendar and in parallel to deliver an engagement process template for use in subsequent seasons to ensure engagement and consultation with all stakeholders of the domestic calendar.

The CRG drafted an engagement timeline for building the Calendar over a number of months, iterating a number of drafts taking input from all stakeholders including: HP Director, current HI Competition Committee Working Groups (IHL, Cups, Indoor, Interpros, Schools & Colleges, Technical Officials), Umpires Association and the Provinces. See the timetable for the Calendar and the stakeholders involved in Section 5.

The Calendar has been built based on Guiding Principles detailed below in Section 3. It is recognised that in building the Calendar compromises are required, given that player cohorts cross over between HP, JAG, clubs, schools and colleges. This final Calendar sent for Board approval is the best compromise that can be achieved following engagement and consultation with all Stakeholders.

The certainty of HP plans at this early stage cannot be secured as timing does not align with a) the Sport Ireland multi-annual funding cycle, b) ProLeague (PL) qualification is unknown until June, and c) other NA's commitment to test matches /warm weather training camps is unachievable until later in the year. 2024/25 PL participation will require two availability blocks for Ireland participating teams - February and June 2025 - and the Calendar has been built to be adaptable with minimal impact and changes required should one or both teams be playing in the PL.

The approved Calendar and these Guiding Principles and explanatory notes for the operation of the Calendar will be published on the website.

The annual Calendar must be agreed by mid-May, so that competition planning and scheduling can take place across HI, provinces, schools and colleges.

The Provinces are required to build their own competition calendar aligned with the HI Calendar and to adhere to the Calendar operational decisions as covered in Section 4.

Once issued, IT SHOULD BE NOTED HOWEVER, THAT THE CALENDAR REMAIN SUBJECT TO CHANGE.

The website should always be used to reference the latest Calendar and any change will be announced.

3. Guiding Principles for Developing the Calendar

- 1. *Where possible*, the HI Calendar should be the same for men and women club competitions and particularly to keep key events together, e.g. EYHL Champions Trophy, ISC Finals.
- 2. In building the calendar, the competitions are prioritised as follows:

3. HI Outdoor club competition will have a mid-season break to manage player load and the period for bad weather and unsafe travel conditions to minimise number of postponements.

- 4. HP players will be available for all rounds of the IHL (Div 1), playoffs and Champions Trophy as well as the ISC semi-finals and final. The HP players MAY be made available for ISC KO16 and KO8 and this will be announced in December 24.
- HP players must be made available to represent their club in EuroHockey competition up to 15th May. Any requirement beyond that date, will be subject to agreement with the HP Director.
- 6. Clubs representing Ireland in EuroHockey competitions will be able to reschedule any clashing domestic competition match. The re-scheduled date will be determined by the Clubs Outdoor sub-group, having consulted the HP Director, if appropriate.
- 7. HI Indoor Competition to be aligned to EuroHockey Nations and Club tournaments to ensure Indoor players can play domestically and in international competitions.
- 8. JAG Sunday training dates have been provided to avoid inadvertent scheduling / re-scheduling of club competitions on these dates and thus helping to prevent clashes. No other dates, other than those in the Calendar have priority over club competitive hockey.
- 9. St. Patrick's Day is specifically reserved for provincial club hockey.
- 10. It is recognised that IHUA does not have sufficient umpires to cover all HI competitions and priority will be applied. Cup regulations include when umpire appointment is club responsibility.

4. <u>'Rules' and guidelines for the operation of the Calendar</u>

The following rules and guidelines should be read in conjunction with the Calendar. There is also a 'Notes' column to the right on the Calendar Spreadsheet.

Any issue, query or challenge should be addressed to the Competitions Committee Chairperson in the first instance.

Clubs – Outdoor

- The HI season has two phases with a mid-season break in all island competition from 8th December through to 8th Feb for EYHL1 teams and 25th Jan for EYHL2 and IJC.
- Mid-season break opportunity:
 - Provinces encouraged to use the break for local competitions, particularly Cups, to support clubs in player and squad development.
 - o The indoor HI and provincial competitions schedule provide further player competitive and development opportunity.
 - o Rest and recovery option is available / suitable for some players
- One double weekend has been scheduled for EYHL1 pre-Christmas, with a date for a possible March double weekend flagged, should HP have matches (PL, tournament or training matches) in February.
- HP carded players will be available on 20 weekends for HI club outdoor competitions (17 x EYHL1 weekends, 2 x ISC Saturdays, 2 x Champions Trophy playoffs and finals weekend). The HP carded players may be made available for the ISC KO16 and KO8, and if so, this will be communicated in December. Note: request / restriction may apply to an individual player at any time due to specific circumstances, such as injury, load, etc.).
- The EYHL Champions Trophy will take place on the May Bank Holiday weekend. As this is the premier domestic competition, no other competitions on the island can take place, to enable all the hockey community attend, particularly club members and supporters from participating clubs.
- EYHL2 will follow the same format as 2023/24. Each province to confirm their entries by 31st December 2024 and the first league matches will start on 25th January. *Note: Any review of the format changes introduced in 2023/24 can only be conducted once the current season finishes.*
- EYHL2 has 1 x double weekend (Round 3 & 4). For Round 4, if both clubs fail to progress through to ISC KO8, then the EYHLD2 Round 4 match will be moved forward 1 week.
- Provinces local league and Cup scheduling to be built aligned with the Calendar and the underlying Principles and Calendar operations rules included in this document. If a provincial Sunday scheduling throws up an unfair situation due to extensive travel for HI competition on Saturday, a re-fix request to be agreed by the provincial committee.
- Contingency dates have been provided for in the Calendar one each side of Christmas to manage player load and minimise backup at the end of the season if postponements happen.
- Re-scheduling of any HI competition matches will be done in consultation with the Clubs Outdoor sub-group and HP, where applicable.

Hockey Ireland 1st XI Cup Competitions – new guidelines

- Open to every club in Ireland to enter the 'Irish Cup' and by virtue of provincial ranking position at end of the previous season, the club is assigned to the appropriate Cup (Senior, Trophy, Challenge I, Challenge II), with each Cup limited to 16 clubs.
- This provides:
 - More balanced number of matches and attractive competition with realistic chance of winning to encourage entry and helps with over /under playing issues for players and clubs
 - o Improves the situation for Fixtures Secretaries /Administrators regarding re-scheduling and helps improve planning and management of facilities
 - Finals can be held earlier in the Calendar than previously with less 'waiting weeks' at the end of the season for suitable cup final dates
- Choice of venues for Finals will seek to ensure participating clubs can maximise attendance from their supporters.

Clubs - Indoor

- The HI Indoor tournament format is being changed from this season. There will be a Final 6's Sunday and a Final 4's Sunday to determine the Irish Champions, thus ensuring full regional representation for finals.
- Provinces will need to plan for their Indoor qualifying competitions within their own Calendars and to complete no later than 26th January 2025.

Schoolboys & Schoolgirls competitions

- The dates for Kate Russell, Schoolboys, John Waring and June Smith are included on the calendar.
- A competition extending number of senior schoolgirls teams is being piloted this year (Daphne Hall), subject to sanctioning of the event by Hockey Ireland

Intervarsities

• The Intervarsities will return and run as a pre-season tournament in September.

U16 & U18's Interpros

- The JAG competition and training dates follow the approach for the last few seasons.
- Note: A review of the JAG pathway and Interpros is planned to commence this year and complete before end 2024.

Master Interpros

- Note, the Masters program is NOT run by the HI Competitions WG and dates are not known. Dates for the Masters must not clash with HI competitions.
- This requirement will also minimise difficulty in securing Umpires and Officials for Masters events.

The Calendar was built over a period, taking drafts through iterations and consultation as below.
